141/2023 USE OF RFECREATION FIELD

Members had been circulated with a letter regarding the use of the Recreation Field by children on Quad Bikes. The contents were discussed and whilst it was disappointing that the person had found it necessary to complain it was noted that there had been no other complaints or damage to the field. On balance it was agreed to continue to monitor the use.

143/2023 RESTORATION OF THE BONFIRE SITE

R. Bowness advised that he had applied for more trees and would be putting a smaller gate to the area. He will also provide a plan of the area.

144/2023 SPEED INDICATION DEVICE - MEALSGATE

The SID has not been returned as promised. The clerk had written to the Police on two occasions and has had no response. It was agreed that the issue should be raised with the Deputy Police and Crime Commissioner who has previous knowledge of the issue.

145/2023 DRAINAGE - PLAY PARK, FLETCHERTOWN

It had been reported that the drainage system on the play park was regularly becoming blocked by the roots of the Willow. It was agreed to kill back the Willow and then have the drains cleared in spring.
