16/2024 RESTORATION OF THE BONFIRE SITE

This is an ongoing project with more trees arriving in March.

17/2024 SPEED INDICATION DEVICE - MEALSGATE

The clerk raised the issue with the Deputy Police and Crime Commissioner who eventually contacted the officer responsible for the deployment of the Speed Indication Device (SID) who will raise he matter with CRASH and arrange for its return in the future.

21/2024 DONATION WIGTON BATHS

A letter seeking financial support had been received from Wigton Baths Trust. As this facility is used by some local residents on the proposal of M. Abbott and seconded by J. Mansfield it was agreed to donate £50.00 to this worth cause.

J. Mansfield advised that ongoing research was being carried out to identify those from the parish that were lost in the war although this is being frustrated as the government had given the records to a private company who now charge for the information.

The clerk had received a letter from the present contractor advising that he would no longer be cutting the grass in the parish. It was agreed to employ Mike Dowling Contracting to cut the grass in the parish for the 2024 season.
