84/2023 PUBLIC PARTICIPATION

At the beginning of this item the chair read a notice that the council was aware of an incident on the recreation field on Saturday 3rd June which was being investigated by the Police and Monitoring Officer and as such the council was not prepared to listen to any information/discussion regarding the incident which may prejudice the outcome of those independent investigations.

There were three members of the public present, who raised the following matters: -

- (i) Could the public seat at George Moore Avenue i/w B5299 be heightened.
- (ii) Could the Parish Council public notices be displayed on the Allhallows Centre noticeboard as it is difficult for elderly and disabled residents to access the noticeboard in the village.
- (iii) Residents in Fletchertown were unaware of the recent Parish Council Elections as there were no notices on the noticeboards. It was explained that previous notices were issued by Cumberland Council (formerly Allerdale) but none had been supplied this time. There were, however, adverts on television and in the local press.
- (vi) The use of the Recreation Field by quad bikes was raised. The clerk reiterated the information/advice given on 7th September 2022, including that users should have their own insurance.
